**AFTERCARE**

Rapha House operates several safe houses for girls that are rescued from sex trafficking and other forms of exploitation. The safe houses provide a safe place for these girls to recover and heal through counseling, advocacy, nutrition, and education. Smiles and laughter may be the last things you would expect to encounter at a safe house for trafficked and exploited children, but these places are filled with joy. Each safe house gives girls the chance to reclaim their lost childhood. Each day the girls are treated with love and value instead of abuse and neglect. Our safe houses are staffed by local experts from the community who understand the culture and know how to work with children. We also provide educational and vocational opportunities for the girls to ensure that graduates remain free from exploitation after leaving the safety of our centers.
