BCWA has a written policy describing how the organization monitors, inspects and handles violations and outlines the steps required to enforce the conservation easements. These policies are reflected in each individual easement document. BCWA has taken steps to supplement their ability to defend and enforce these easements by aligning with the Land Trust Alliance and TerraFirma RRG LLC to pool resources and purchase insurance coverage to facilitate protection & enforcement functions.

Form 990, Part VI.A.6-7b. Beaver Creek Wetlands Association consists of members who are offered the opportunity to appoint Trustees by a simple majority vote annually. The elected Trustees serve two three year terms and elect the officers that lead the organization and serve on the Executive Committee. The Trustees represent the members at large for all activities of the Association. The Trustees meet monthly as a group and routinely serve on one or more sub-committees that meet separately as often as needed to serve specific functions. Minutes of each Executive Committee and Trustee meeting are recorded by the Secretary, approved by members and preserved in accordance with the Record Retention Policy. Committee meeting minutes are recorded by a Committee member and incorporated into the Trustee meeting minutes during each meeting as a Committee report. Minutes and results of elections, voting, etc. are preserved in Association files pursuant to the Record Retention Policy.

Form 990, Part VI.B.11a. Form 990 is reviewed and approved by the BCWA Administrator and the Executive Committee (consisting of the current officers plus the past President) before presentation to the Board of Trustees. The Board of Trustees reviews and approves the Form 990 (by majority vote) before it is filed. A copy of the Form 990 is made available on the BCWA website and at the Annual Meeting for review by all members and is available upon request.

Form 990, Part VI.B.12c. Beaver Creek Wetlands Association requires that each officer, trustee, employee, and affected member sign a comprehensive Conflict of Interest and Gift Policy and Disclosure form annually. These documents are reviewed and accepted by the Executive Committee (as described above) and retained in vital files. The Trustees and members share the responsibility of monitoring compliance with these policies with any concerns heard and addressed by the President, Vice President, or any member of the Executive Committee. This process serves in conjunction with the BCWA Whistleblower Policy to provide adequate coverage for all BCWA members.

Form 990, Part VI.B.15. Beaver Creek Wetlands Association employs only one person and only on a part-time basis. Compensation rate for the BCWA Administrator is established and approved by the Board of Trustees, based on current market rates for comparable services and level of responsibility. The Executive Committee reviews the Administrator compensation rate no less often than annually and adjusts accordingly as approved by unanimous consent of the Executive Committee.
