In the 10 years of our existence, we have raised \$5.5 million in grants and donations and utilized \$7.0 million of in-kind donation services and facilities for ramps constructed. These resources funded the start-up and development of 38 regional operations using volunteer labor to construct approx. 9,568 ramps at no cost to the recipients. In 2016, volunteers built 1,850 ramps. Year to year growth has been solid and consistent and is expected to continue through 2017 and beyond.
