Clients housed in the program are provided with both housing subsidies and supportive services, which are all required to successfully house these households. Support services provided include case management, therapy, nutrition education and referrals to a range of additional services such as health care, substance abuse treatment, mental health, child care, legal assistance, work force development services and educational programming.
