In 2016, HRI boldly focused on positive outcomes and sustainable change for children in Guatemala and Haiti. Areas of focus included the provision of nutritious food to over 2,500 children, provision of, and access to clean water, for hundreds of children and families, sanitation training and infrastructure, personal hygiene kits, improved and strengthened shelters, and access to education. All of these activities were dedicated to creating healthy environments in which children could grow and thrive. In addition, HRI provided emergency support to 1,500 children after Hurricane Matthew hit Haiti. Support included large amounts of clean water, food, and personal hygiene kits.
