Over the past several years, BASTA has focused its mission on helping low-income tenants in the County of Los Angeles regardless of race, age, gender, sexual orientation, ethnicity, nationality, immigration status, or anything else. Among other areas of activism, BASTA does the following (in no particular listed order): (a) Provides legal counsel and trial representation to defend tenants (often in rent-controlled properties) suffering through eviction proceedings who could not otherwise afford such legal representation, (b) Promotes, advocates, and defends the Constitutional right to a jury trial under the Federal and California Constitutions by requesting and conducting jury trials in virtually every unlawful detainer action, (c) Undertakes appellate work when Courts deny tenants a jury trial (several of our cases are now published appellate decisions), (d) Promotes, advocates, and defends indigent access to the Court system by defending such indigent persons.
