LOUIS (CAM), A NON-COLLECTING INSTITUTION, IS INTERNATIONALLY RECOGNIZED FOR EXHIBITIONS OF THE MOST PROVOCATIVE, INSIGHTFUL, AND URGENTLY RELEVANT CONTEMPORARY ART BEING MADE TODAY. DURING FISCAL YEAR 2016 (THE 2015-2016 SEASON), CAM PRESENTED TWENTY EXHIBITIONS, FEATURING PRESCIENT AND SEMINAL WORK BY EMERGING AND ESTABLISHED ARTISTS, RANGING FROM PAINTING AND SCULPTURE TO SOCIAL PRACTICE AND PARTICIPATORY ART, WITH FOUR SITE-SPECIFIC INSTALLATIONS THAT TRANSFORMED THE FACADE AND COURTYARD. FROM IN-DEPTH PRE-PROFESSIONAL TRAINING LIKE NEW ART IN THE NEIGHBORHOOD AND TEEN MUSEUM STUDIES TO BROAD SCHOOL OUTREACH INITIATIVES LIKE ARTREACH AND THE MOBILE ART STUDIO ARTBUS, CAM IS PROUD OF THE MEANINGFUL WAYS ITS PROGRAMS MAKE A DIFFERENCE TO ST.
