Orange County Communities Organized for Responsible Development (OCCORD) is a community-based organization that brings together workers, families and community partners to organize and advocate for good jobs, strong neighborhoods and an inclusive democracy in Orange County. We provide leadership development training to low income residents and workers, and we train residents and stakeholders on community organizing, participatory research, nonpartisan political reform, and land use planning and economic development policy. OCCORDs Anaheim and Santa Ana programs develop leadership and build organizational structures to engage residents and stakeholders in land use planning and economic development decisions that affect their lives. Through strategic, coalitional outreach, we train local and regional groups to work collaboratively, and through targeted, neighborhood-based outreach, we train new leaders and build sustainable organizational infrastructure in low-income communities of color. During 2016, OCCORD engaged in nonpartisan voter education, teaching Anaheim residents about the new district election system in the city. We hosted and assisted with candidate forums, and coordinated a Get Out The Vote campaign to encourage residents to participate in November's election. This work built upon our past successes advocating for the establishment of district elections in Anaheim. We also continued our work providing residents with training and technical assistance to advocate for their neighborhoods needs at City Hall through civic engagement. In Santa Ana, we led a coalition of residents and organizations to advocate against the sale of surplus public lands in the city, and developed a proposal for the establishment of a Community Land Trust to preserve public spaces for community uses. We won a commitment from the city to donate parcels of land to the Community Land Trust, and began the process of establishing a 501(c)3 nonprofit organization to govern the Trust. OCCORDs Citizenship Program provides naturalization assistance and civics classes, as well as training and leadership development enabling immigrant workers and residents to become full participants in the democratic process. We work with local and regional organizations to provide these services to their members and constituents. In 2016, OCCORD organized five large, volunteer-driven citizenship fairs followed by 8-week citizenship classes, plus eleven smaller clinics. We provided naturalization application assistance to 1652 people, provided fee waiver assistance to 147 people, taught civics classes for over 300 people, and partnered with more than a dozen organizations. Our volunteers ranged from those with no previous experience to some with professional level skills such as teachers, lawyers and paralegals. We also began working with a new, additional partner to provide legal services, bringing our legal partnerships to a total of three, and attained Bureau of Immigration accreditation as an organization. All of OCCORDs citizenship services were provided free of charge to participants.
