The Step Ahead program operates through a model of individual assistance and aims to take a comprehensive approach to ending poverty. Social workers, lawyers, psychologists, teachers & support staff work together to support 208 disadvantaged children. In 2016, this support included \$10,323 on nutrition, \$600 on the Transition House, \$1,289 on shelter, \$12,092 on long-term support, \$7,588 on social activities, \$109,374 on emergency support for street children including safe accommodation, clothing, child advocacy and counselling, \$2,221 to support children with disabilities, and \$25,797 for Youth Development.

Sponsorship program providing support to children in Bac Ninh Province at high risk of dropping out of school or who have recently quit due to poverty. There are 390 children in the program. Support includes school fees, bicycle and medical insurance.

4c (Code:) (Expenses \$ 194,320 including grants of \$ 194,320) (Revenue \$)**Safe and Sound Program**

This is an antitrafficking program in Hue and Dien Bien Provinces. In 2016, Blue Dragon rescued 89 from forced labor or sexual slavery. Blue Dragon provides support to former victims who return to school or vocational training, and provides medical assistance and counselling.
