Two grants were given to the Children's Hospital of Philadelphia in 2016, one to support the infrastructure of the Children's Brain Tumor Tissue Consortium (\$20,000) and the second is the first installment of a two-year grant to fund a post-mortem tissue donation initiative for the Children's Brain Tumor Tissue Consortium (\$140,000). Swifty Foundation also supports the promotion of clean water access in East Africa. In 2016, \$20,000 was granted to Change a Life Uganda to support a water reclamation project in Mygera, Uganda. 100% of every donation is used for grant awards and programs. Administrative expenses are paid with funds donated by the Organization's founders.
