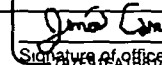
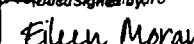

Joy of Voting - program created to reinvigorate a culture of voting. We partnered with artists, activists, designers and citizens in four cities across America - Akron, Miami, Wichita and Philadelphia - to launch initiatives to create creative, communal experiences and rituals around local voting. Meetings with local innovators began as brainstorming and resulted in festivals, performances and art installations. These four cities became a pilot project for community involvement in the culture of voting and the reclamation of democracy.

Conference - The Citizen University National Conference served over 500 citizens from around the country during the two-day gathering in Seattle. The annual conference continues to sell out, and has grown in size, scope and importance, bringing together voices from the left, right and center to rekindle citizenship and remake the narrative of America.

The Civic Collaboratory - a national network of catalytic leaders from across the political spectrum and many domains is now in its fifth year. Having grown from a handful of participants into a membership of over 200, the quarterly meeting provides a common platform and project incubator for this diverse community of civic innovators.
