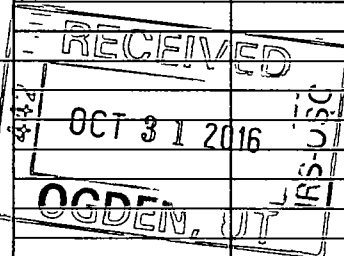

Provided grantmaking services for companies that engage their employees in the grantmaking process, including reviewing the preferred charities identified by employees, auditing selected charities for compliance with local laws and standards, tracking payments made to charities, and providing full and transparent accounting of all grants made. Processed 65 grant requests to 22 charitable causes with the objective of expanding the pool of funding made available to charities by tapping into funds that would otherwise be used for employee motivation programs. Linking employee rewards to charitable giving will create greater employee loyalty and higher employee motivation.

4b (Code:) (Expenses \$ 6,459 including grants of \$ 6,364) (Revenue \$ 0)
Provided grantmaking services for small businesses that engage their customers in local philanthropy, including creating a local list of approved charities for customers to select, auditing listed charities for compliance with local laws and standards, training listed charities in marketing and communication efforts in support of the small businesses participating in the local campaign, tracking payments made to charities, and providing full and transparent accounting of all grants made. Processed 14 grants to charities by engaging 95 businesses in a collaborative effort that tapped into funds that would otherwise be used for coupons, sales promotions, and advertising and directing those funds to local charities. Linking purchases to the desire of customers to give back to their community will create greater customers loyalty and awareness.

4c (Code:) (Expenses \$ 100 including grants of \$ 100) (Revenue \$ 0)
Provided incentives to fans and ticketholders of SuperBowl50 so that they reduced their carbon footprint during the festivities. The SuperBowl50 planning committee provided the majority of the funding for these incentives which were gifts directed by participants to local San Francisco charities. In total, 21,700 charitable acts were completed as a result of rewarding participants for good behavior. The GoodCoins of The GoodCoin Foundation were a means to build awareness of the impact of travel, use of recyclable materials, and reduction in energy use as well as funding and building awareness of local nonprofit organizations with energy and resource conservation-related missions.
