In 2016 our largest program, from an expense point of view, was LLA's rip rap program. Each year wave action and normal shoreline erosion results in thousands of tons of silt which has relocated from the shoreline, to the lake and it's tributaries. This degrades water quality and over time, fills in the lake and reduces its storage capacity. As one of the busiest Corp lakes in the country, unchecked this would have a devastating effect on Lake Sidney Lanier.

This year we began our largest riprap project to date on much needed islands in the southern part of Lake Lanier. We expect to complete these projects in early 2017. Based on favorable results so far, we would like to extend this shoreline protection program to other islands in 2017.

This program is largest in expenses in due to large expense outlay in 2016.

4b (Code:) (Expenses \$ 63,425 including grants of \$) (Revenue \$)

In 2016, our second largest program, from an expense point of view, was our Shore Sweep (annual lake cleanup) and related clean lake activities. The year, over the course of the summer culminating in September, over 500 volunteers removed over 50 tons of trash. Because of favorable results, we've expanded our clean up efforts to several additional smaller events.

We've also expanded our efforts to remove derelict, abandoned vessels and docks. So far, we've organized community efforts to remove 14 abandoned vessels and docks. Removing these dangerous, abandoned hazards also serves to improve the safe use of our lake.

In 2016, we continued to employ our Adopt a Lake program, which serves to monitor lake quality, especially in terms of chlorophyll a.

In 2016, our third largest program, from an expense point of view, was our lake safety light program, which included the deployment of 160 solar powered safety lights. Each one was placed on lake hazard markers, to provide warnings to night boaters of impending hazards. This program was created in response to several fatalities on Lake Lanier over the past few years. We believe this has made Lake Lanier much safer.

We also promote safe practices and strategically distribute safety materials to promote the safe use of Lake Lanier. This includes the distribution of safety stickers to lake marinas for use in their rental fleets to help protect the boating public. We also distribute safety stickers and other materials to the public during our various community events.
