Upon the closing of the estate, the intellectual property and related purchase agreement passed to Mrs. Anne Kennedy, the beneficiary of Dr. Kennedy's estate. During the year ended June 30, 2016, the Organization paid \$120,000 to Mrs. Kennedy in connection with this agreement. As of June 30, 2015, \$354,796 is payable to Mrs. Kennedy in connection with this agreement. This obligation is reported at Part X, Line 22, and at Schedule L, Part II.
