Caregiver Respite Program: provided non-acute, non-medical in-home caregiving services to more than 400 seniors (562 are presently enrolled) with chronic illness and/or disabilities by matching them with trained volunteers. Services included phone reassurance, home visits, errands that included grocery shopping, light housekeeping, yard work, home safety repairs, bill paying, meal preparation, Medi-Cal (Medicaid) application assistance, information and referral, respite for family caregivers. Provided more than 2,108 hours of phone reassurance calls which totaled 8,432 calls, and more than 3,288 hours of home visits

4b (Code:) (Expenses \$ 55,775 including grants of \$) (Revenue \$)
Ride with Pride Program: provided curb-to-curb, door-to-door, door-through-door medical rides for ambulatory seniors who no longer drive. Door-through-door transportation provided to Caregiver Respite Program care recipients, and curb-to-curb rides include those enrolled in the Senior Peer Counseling Program who were accessing mental health services. Seniors could also be transported to life enhancement activities, such as bookstores, libraries, hair salons, etc. Approximately 6,800 rides were provided.

Senior Peer Counseling Program: provided in-home peer counseling to 12 homebound seniors and their family caregivers dealing with early on-set of mild mental health issues such as depression, sadness, and loneliness. The program also provided group counseling to 85 seniors who dealt with grief/loss, caregiver's stress, impact of isolation. The program also provided virtual group counseling to 14 homebound seniors in a pilot known as Senior Voices.
