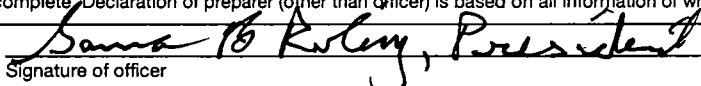

To provide a place in perpetuity where people with disabilities can be successful, equal and capable, growing to their maximum life's potential through interaction with horses in a positive environment. We accomplish our mission by providing recreational, educational, and sport programming, including vocational/pre-vocational opportunities, to youth at risk and persons with disabilities. Individuals are accepted without regard to race, religion, ethnicity, or socioeconomic background

Teaching people with disabilities to ride and care for horses and preparing them to show at the Top Hands Horse Show - In 2016 the weather cooperated. We taught 522 lessons to 41 riders with disabilities. A team of 20 riders participated in the Top Hands Horse Show (HLS&R) earning 8 first, 4 second, 7 third, 6 fourth, 10 fifth, 7 sixth, and 13 honorable mention awards. Additionally families took pride in these accomplishments, relaxed and enjoyed being a part of an accepting community as well as encouraging further education with potential employment goals. The families also organized our first on site open house in December. The school age students gained in positive behavior and communication skills as well as other areas.

Providing adjudicated youth with the opportunity to serve their assigned community service hours - This included teaching them to use a garden rake and shovel to clean and repair the facility. Ten youth and 1 adult completed 125 hours of community service. They removed vines and grass from our fence line, weeded around and under our ramps, cleaned our horse trailers, and on special occasions helped with the horse program. Upon completion of the program they have a better understanding of how to stay out of trouble. Success rate is 95% returning them to positive life pathways.

Utilizing volunteers to feed and care for our horses, instruct our people with disabilities, supervise adjudicated youth, maintain the facility, and complete all administrative and fundraising work - A total of 134 volunteers (including the adjudicated youths and adult) gave a total of 4,174 hours to operate Dream Catcher Stables program. This does NOT include administrative or fundraising work. Of the totals given we had 15 very dedicated volunteers who gave 2,773 of the total hours to our program. Formal records of volunteer hours date back to 2004. Cumulative statistics indicate there have been 866 volunteers (including adjudicated youth). 237 of those volunteered at least two years and 40 volunteered 5 years or more. Many of our volunteers are high school students who leave us when they go on to college. While in our program they learn how to effectively interact and work with people with disabilities AND learn the capabilities of our athletes. In recent years two of those volunteers have chosen therapeutic fields because of their work with us.

Fifteen key volunteers contributed 2,773 of those hours. Of those key volunteers board members invested 1,529 hours. Administrative hours are not recorded. All volunteers sign in and out at the facility. Records are then transferred to a spreadsheet for compilation of hours by individual, month and totals for the year.

990 Part VI Line 1 - Executive Director, Pete Trumper, is responsible for Facility Maintenance and is NOT a voting member of the Board of Directors. Board President and Registered Agent, Sanna Roling is responsible for program including horse maintenance, filing our 990 and is a signer on our bank accounts. Pete Trumper and Sanna Roling are responsible for daily operations of the organization. The executive committee consists of the Board Officers and Pete Trumper.

Part VI Line 2 - Voting Board Member and Treasurer Lynne Trumper is married to Ex-Officio Board Member and Executive Director Pete Trumper.

Part VI Line 6 - With the By-Laws revision of 2015, two membership categories were established. Volunteer members meet the requirement of 20 donated hours. (This membership renews annually. Cessation occurs if the volunteer fails to be active for nine consecutive months.) Participant members meet the requirement upon completion of ten lessons and continue so long as the Participant member is active in Dream Catcher Stables program. (Each family having at least one participant in the program and meeting the stated criteria has one vote. The vote may be delegated to the participant or any family member.) Members have the right to participate in the Annual Meeting and must be advised and given reasonable time to act prior to major change in the mission or potential dissolution.

990 Part X line 10b - We elected to expense rather than depreciate our assets. Therefore their original price will be removed when they are no longer in service. The reason for this election is because replacement of like asset would be more than the purchase price. Assets include 6 registered horses donated for a total appraise value of \$204,800. As they age, they actually become more valuable to our program. The 1996 Ford 250 truck (purchased April 2009 for \$4,270), 4-horse home built trailer (purchased 2012 for \$2,500 and refurbished in 2014 at a cost of \$2,000), 3-horse CM trailer (purchased April 2009 for \$1,800 and refurbished in 2014 at a cost of \$2,000), 2-horse Calico Trailer (purchased new November 2014 for \$6,324), John Deer Tractor with implements (originally purchased new August 2009 and stolen twice) returned January 2013 value \$18,871, a FEMA trailer (donated value \$3,500) two cargo containers, a wood frame shed row of 10 stalls, a sound system purchased in December 2014 for \$600, saddles and bridles comprise the remainder of our assets.

990 Part XII 2a, 2b, 3a - President and Registered Agent Sanna Roling compiles our financial statements using reports from Quickbooks which is our accounting program. Treasurer Lynne Trumper monitors our bank accounts and reports to the Board.

The Board receives financial statements for review. Bank statements are reconciled monthly. Check stubs and deposits are matched with applicable receipts and filed for review and storage at year end While we welcome an independent audit, the cost is beyond our financial capability at this time.
