 Stop GE Trees Program In April we submitted more than 100,000 letters rejecting the legalization of GE eucalyptus trees to the Brazilian Biosafety Commission In June we consulted with GE Free New Zealand on their efforts to defeat a proposed change in the NZ Forest Code that would prevent communities from banning GE trees Then in September, we attended the World Forestry Congress in Durban, South Africa where we had important face-to-face meetings with allies about the problem of GE trees We also met with World Rainforest Movement on plans to stop GE trees in Brazil In September GJEP also organized and hosted a GE Trees Action Training Camp in North Carolina 40 people attended the camp In October we organized a tour on GE trees throughout the Pacific Northwest, stopping at 14 locations and speaking to more than 1,000 people In February we organized a media webinar on GE trees featuring scientists and other experts in the field, that brought in large media outlets New York Times, Wall Street Journal, Bloomberg, AP, Time Magazine
