The films are intended mainly for general family viewing with popular matinee showings while special film showings accompany seasonal fund-raising events for holidays and other seasonal activities

Live Theater Productions. The organization presents and produces live theater productions in the Touchet Valley and surrounding area for recreational entertainment for members and guests that might not be otherwise able to attend such events in the local community.
