Dedicated the LaFetra Nature Education Center & Gardens. Conducted professional development training in native plant horticulture for approximately 90 landscape staff and residents of the Housing Authority of the City of Los Angeles. Held 93 classes, including 20% new offerings, for 1,190 adults. Held seven field trips for 420 students. 145 volunteers donated 3,050 hours. Four Eagle Scouts earned their badges through service projects. Trained three horticulture interns. Organized three exhibitions in the Theodore Payne Gallery. Completed the 33rd year of the Wild Flower Hotline.

More than 2,100 people visited 41 gardens on the 13th annual Native Plant Garden Tour. Worked with six Title I schools to design and install gardens. Taught 1,480 students at 13 schools. Provided training and seeds for one community wild flower seeding project. Staffed 40 outreach events that served 6,000 residents of LA County. Delivered 55 public talks clubs that reached approximately 1,000 people. Had a booth on nine Sundays at the Hollywood Farmer's Market that exposed approximately 9,000 market-goers to native plant horticulture.

Produced 68,100 of the 100,570 plants sold. Refurbished and replanted one acre of demonstration gardens. Distributed 115 plants to the eleven gardens in the Garden Share Network. Updated 19 educational plant guides - including three in Spanish - for distribution on-site, off-site, and online.
