ALSO OFFERS A TEN WEEK SUMMER PROGRAM TO FAMILIES IN THE CITY OF BOSTON WHICH INCLUDES WEEKLY THEMES, ADVENTUROUS ACTIVITIES, FIELD TRIPS, ACTION PACKED SPORTS AND GAMES. THREE DIFFERENT SUMMER CAMP OPTIONS INCLUDE DAY CAMP (AGES 5-10), SPORTS CAMP (AGES 7-10), AND KIDDIE CAMP (AGES 3-5). DURING FISCAL YEAR 2017, THERE WERE 5402 REGISTRANTS FOR THESE PROGRAMS.
