Films Ltd for English subtitles for the 5-part documentay film "Yerusalem" , \$8,512 was awarded to the AAEJ-AJHS Archives Project; \$6,789 was granted to organize the Fourth Annual Ethiopian Israeli Organizations Conference in Israel; \$1,500 was granted to the documentary film "Heroes" about the Ethiopian Israeli heroes and leaders of the Ethiopian Jewish alyiah, and \$595 was used to provide access to the Foundation Center Directory Online for Ethiopian Israeli organizations and activists.

Part VI, Question 11a: Describe the review process for the Form 990. The Form 990 and all schedules are reviewed by the FEJ Treasurer and the Executive Vice President. Upon the Treasurer's approval, the Form 990 is sent to the entire FEJ Board of Directors for their review. After revisions (if needed) are made, the Form 990 is reviewed by the Treasurer and Exec VP once again. Upon their satisfaction, the Form 990 is sent again to the entire FEJ Board of Directors for any final comments or corrections. After this final review, the Form 990 is filed with the IRS.

Prior to any vote regarding engaging consultants, making grants, or purchasing any goods or services, all FEJ Board members are asked if they have any personal, family, business or other interests that could give rise to a conflict of interest or prevent them from being totally impartial.
