SHELTERS - In FY17, BRC operated four shelters with a total of 521 beds in Manhattan and Brooklyn as well as a 200-bed assessment center in Brooklyn. At our shelter programs, we offer residents a complete range of employment support services, case management, and medical and mental health stabilization aimed at moving them into independent housing. BRC's four shelter programs made 433 placements of clients into housing and other more appropriate settings in FY17. At the Assessment Center, BRC evaluates each individual and links them to the housing and services that best meets their needs, both in and outside of the shelter system. Our Assessment Center made 3,222 diversions of clients out of the DHS shelter system in FY17, including 252 people who were placed directly into new housing opportunities.

Form 990, Part III, Line 4b:

NONRESIDENTIAL PROGRAMS - The BRC continuum of programs also includes a variety of other social service programs that provide homeless and other at risk individuals with the tools to achieve their highest possible level of recovery and independence. Among the most significant of these programs are our homeless outreach operations, where BRC outreach teams work with homeless individuals to motivate them to accept services that will get them off the streets both initially and for the long term. Last year, these operations worked with more than 10,000 individuals and made 3,303 placements of street homeless adults into needed services. Other nonresidential programs at BRC include licensed inpatient and outpatient substance abuse treatment, a workforce development program, and case management services for mentally ill individuals and seniors. In FY17, these programs served a total of 4,005 individuals.

PERMANENT HOUSING - BRC is a major provider of housing for people with a history of homelessness, providing nearly 550 units of supported permanent housing throughout New York City. We have a wide variety of housing options that enable us to be highly responsive to each client's issues and readiness for independent living. These housing programs are a key resource for graduates from BRC safe haven, shelter, and transitional housing programs, and often serve as the appropriate next step for housing. In FY17, BRC served 591 individuals at its permanent housing programs.
