To ensure that happens, we actively work on advocating for older people and aging services and develop policy initiatives to address unmet needs. Every area of our advocacy and public policy links with our programs and is conducted in collaboration with partners so that we can maximize and leverage resources. Our work is carried out through the following key activities: Active engagement with community based senior service organizations to inform policy campaigns and research, Annual City and State policy campaigns that correspond to the budgetary and legislative process, Development of research and publications to inform policy decisions, Effective use of communication strategies including traditional and social media (such as Facebook and Twitter), Outreach and training for older community members to learn more about aging policy issues, Ongoing education for public officials on the needs of older adults and the services upon which they rely to aging within their communities. As a result of this work, LiveOn NY presents a unified voice on budgetary, legislative and policy issues that affect elderly New Yorkers including but not limited to community based supports, caregiving, health and wellness, elder hunger, economic security, affordable housing, quality of life and civic engagement. Accomplishments and highlighted work include City and State Advocacy. Each year, LiveOn NY organizes year-long campaigns to ensure that funding for aging services remains a priority for city, state and federal lawmakers, and policymakers at every level of government are educated on the needs of older New Yorkers. Our efforts resulted in winning the restoration of millions in NYC funds to ensure that services are provided and that meals will continue to be delivered so that seniors do not go hungry. The funding will also provide frail homebound seniors with access to social services, deliver health screenings, and provide respite to caregivers. Housing Initiative. Access to Affordable Senior Housing with Services is a necessity for New York City's 60+ population, which will nearly double from 2000 to 1.84 million by 2030. The ability of older adults, frequently the anchors to stable communities and families, to remain in their homes is at substantial risk in neighborhoods of all socioeconomic levels across the city. This initiative is actively working to ensure that New York produces, regulates and preserves affordable senior housing. Elder Abuse Initiative. LiveOn NY is building legal, budgetary and regulatory protections against elder abuse so that older adults can age into their later years without abuse and if it is experienced, that they can access support and services. The Elder Abuse Initiative builds on our history of making impactful and sustained change for older adults by educating key stakeholders, convening critical partners, developing governmental buy-in and creating a space for older women's activism. Family Caregiver Initiative. LiveOn NY is proud to host the New York City Family Caregiver Coalition as an innovative program that brings together interdisciplinary partners to address caregiver supports, services and awareness. LiveOn NY will continue to fill the need for a voice for caregivers in New York State.

Direct Service, Capacity Building & Membership Support LiveOn NY conducts a broad array of programs and initiatives that help older New Yorkers age with confidence, grace and vitality. Included in those programs are direct services to address elder hunger and financial security, capacity building to help ensure that the elderly can access needed community based services, and membership support to address the needs of our over 100 member organizations that provide over 800 community programs to New York's older adults. This work is carried out in the following key ways: Working directly with low-income older adults, Training/supervising volunteers, Providing ongoing, year-round training and technical assistance, Hosting educational and networking events such as Symposiums, an Annual Conference, and Forums to inform participants about best practices and local issues, and Developing ongoing relationships with academic, public and private partners to maximize resources and create new relationships. Through this work, we serve 3.2 million older New Yorkers from every community around the State. Accomplishments and highlighted work in 2014 includes: The Older Adults Benefits Outreach Initiative - This Initiative is an innovative, peer-to-peer model that uses very carefully selected and highly trained retired people to educate and screen older adults from low-income, high-needs NYC communities for benefits eligibility. The Initiative conducts screenings and enrollment at over 60 sites throughout New York City in various high-needs communities. Located in senior centers, community centers, faith-based organizations and libraries, all sites offer familiar, comfortable, safe, senior-friendly locations for peer volunteers to meet one-on-one with older adults to screen for eligibility and assist with benefits enrollment. In 2015 we worked with over 4,000 elderly New Yorkers and delivered roughly \$3 million into the pockets of elderly New Yorkers through benefits. Falls Prevention Program - LiveOn NY created a falls prevention program that uses the Evidence Based Program, A Matter of Balance, to educate older people on falls and balance. Our program also coordinates informational fairs, screenings from geriatricians and optional home visits to further prevent falls in the home. Senior Activators - The Senior Activators Corp is a program that harnesses the power of individual older adults to make change and influence policy decisions. The unique program brings older New Yorkers together and trains and empowers them to get involved in public speaking and policy issues. In 2015, Activators were trained and participated in bring policy information into their communities. Training & Education - Each year, LiveOn NY presents a variety of educational events, trainings and workshops focused on innovative ideas, best practices and real life skills designed to educate senior service professionals and enhance the quality of services provided by New York's aging services network. Highlights include: Annual Conference & Vendor Expo. Each year, the full day event brings innovative practices and perspectives from across the US to the aging field in NYC. Statewide Webinar Education. Thanks to a State funding mechanism subcontracted through the Association on Aging in New York, we provided 6 workshops that had roughly 340 participants throughout the State. Topics included resources for new supervisors, health care reform, and collecting and using data. The HIV/AIDS Older Adults Initiative - In collaboration with the AIDS Community Research Initiative of America (ACRIA), this initiative continues to grow in its work and scope. In addition to the program's traditional HIV/AIDS trainings, the Initiative conducts trainings to HIV/AIDS service organizations to educate those providers on the needs and issues of older adults. Customized Technical Assistance - Technical Assistance (TA) is an integral way that LiveOn NY builds the capacity of community services so that they can provide seamless, effective programs for elderly New Yorkers. LiveOn is unique in providing this assistance free-of-charge and tailored to specific needs of an agency. Through TA, LiveOn NY addresses the issues that our members face which can put their agencies' survival in jeopardy. The Marketplace @ LiveOn NY - The Marketplace is a group purchasing program that was created as a vehicle for members to save money on essential goods and services by harnessing the collective purchasing power of the senior services network. Products and services include food, medical and office supplies, capital equipment, vehicle and disability insurance, delivery vehicles, printing services, back office support functions and more. In 2015, 60 member agencies representing 355 community programs utilized the marketplace to purchase \$9.1 million in goods and services.
