



THE PROGRAM HAS SERVED A TOTAL OF 4,185 INDIVIDUALS SINCE INCEPTION. DURING 2017, 97% OF TOTAL EXPENSES WERE PROGRAM EXPENSES.

THE ORGANIZATION IS COMMITTED TO PROVIDING EMERGENCY FINANCIAL RELIEF TO HELP FAMILIES ENDURING PEDIATRIC CANCER PAY FOR EVERYDAY NECESSITIES SUCH AS MEDICAL, UTILITY, RENT, CAR, GAS AND FOOD. THE ASSISTANCE IS DESCRIBED AS A LIFELINE PREVENTING FAMILIES FROM SPIRALING DOWN AND VITAL TO THE SURVIVAL OF THE CHILDREN IN TREATMENT.
