This past year, 7 mission trips were completed with 15 volunteer dentists, 56 assistants/hygienists and 10 lay people from the US. 3,842 dental patients were seen (1,355 + 2,487) and provided with services including cleanings, extractions, fillings and many other treatments and referrals. Amounts reported exclude in-kind dental care professional services valued at \$181,520.</p> <p><b>OTHER PROGRAM SERVICES 5 Food &amp; Goods</b>During the annual food drive, 25 to 40 volunteers gathered to sort various food items at St John the Evangelist Church in Naples, FL. In fiscal year 2016-17 we shipped 570 boxes or items of food plus 340 school textbooks. An estimated 200 elderly poor receive food from the St Pius X Food Pantry once or twice per month. Reported amounts include non-cash in-kind food valued at \$19,950.</p> <p><b>OTHER PROGRAM SERVICES 6 Medical</b>The medical clinic at St Pius X in Kingston, Jamaica operates 3 days per week, with a part-time local physician who provides care on a deeply discounted basis. The clinic is open to all indigent patients in the poor neighborhood of St Pius, regardless of ability to pay, or church affiliation. We estimate an average of 123 patients visit the clinic per month, i.e. 1,400 patient visits per year. Jamaica Outreach Program supplies the clinic with medicine and much-needed equipment. The clinic dispensary supplies patients with medications free of charge. The Sacred Heart clinic at remote Seaford Town in Montego Bay region saw 240 patients treated, medicines distributed and medical equipment and supplies donated. The Good Shepherd Foundation clinic in Montego Bay received a grant as well.</p> <p><b>OTHER PROGRAM SERVICES 7 Mission Trips</b>Eleven mission trips to Jamaica were made this year, by 94 volunteers. Each major trip is typically 4 to 5 days and volunteers pay for their own airfare, local transportation, meals and lodging in a convent-hostel (except for nurses, opticians, dental hygienists and assistants who received travel subsidies). Expenses totaling \$6,253 are reported here and partial reimbursement from volunteers is reported as Other Revenue. Activities focus on dental and optical care and assistance in repairs, administration, education and other needs.</p> <p><b>OTHER PROGRAM SERVICES 8 Montego Bay Region</b>The Diocese of Montego Bay's poor have recently been supported by JOP.
