THESE ARE THE BUILDINGS OF THE FIRST AND LARGEST PUBLIC HEALTH HOSPITAL IN THE UNITED STATES BUILT DURING THE HEIGHT OF IMMIGRATION BETWEEN 1909 AND 1930. TO DEVELOP AND ADMINISTER PUBLIC PROGRAMMING ON THE UNIVERSAL ISSUES OF IMMIGRATION AND PUBLIC HEALTH. THE PROJECT SERVES AS AN EXAMPLE OF HOW OUR NATIONAL ICONIC MONUMENTS CAN SERVE NEW AND MODERN PURPOSES, ENCOURAGE CIVIC ENGAGEMENT AND ENLIGHTEN CONTEMPORARY ISSUES.
