The goal of the program was to raise awareness about the importance of making climbing accessible and inspire climbing gyms to be trained in Paradox Sports adaptive climbing techniques. Fifteen climbing gyms received adaptive climbing equipment and technical training in 2017, and each is now more prepared to serve climbers with disabilities.
