The year 2017 brought ten new wells drilled by Hope Springs Water teams in the Tolle region of Ethiopia. We are becoming more efficient in ensuring that the wells that we drill are completed before we leave the country, and therefore more clean water is flowing for the inhabitants of the villages we serve. This year, also, we decided that it was time for us to have our own NGO whose legal platform we would be able to work from in Ethiopia. We have, therefore, in cooperation with another U.S. non profit organization and a group of philanthropic Ethiopians, applied for an Ethiopian NGO license from the Ethiopian Department of Societies and Charities. We will soon have our own legal platform from which to work, making our work there much more organized and focused. The list of completed drilled wells for 2017 is as follows: 1.
