The program provides 24-hour shelter, 3 meals per day and supportive services, including individualized case management, designed to move women directly into permanent housing as quickly as possible. The target for length of stay is 120 days, however, Sarah's Circle operates from a harm reduction philosophy, taking in all unaccompanied women in need of shelter and continuing to work with women until they achieve their goals.
