FACT Oregon's mission is to empower families experiencing disability statewide in their pursuit of a whole life by expanding awareness, growing community, and equipping families. It believes that families experiencing disability should set high expectations and establish a vision for the future where all communities are accessible and welcoming. As Oregon's only statewide, cross-disability, family-driven, non-profit organization, it provides programming "by families for families" that helps parents with a child experiencing disability attain that whole life. FACT Oregon's staff and board members are all parents of children experiencing disability or are deeply involved in advocacy on behalf of this community. Thanks to FACT Oregon staff's strong experience with outreach, community building, and family engagement, it is able to provide peer-delivered family support to Oregon families raising children who experience disability. It does this by supporting connections to resources, referral, information, training opportunities, and family-to-family connections. FACT Oregon provided support in all 36 Oregon counties, had over 16,000 individuals connect with us and 5,627 parents and professionals attend an activity. In addition, 6,342 received direct special education supports. Throughout the year, FACT Oregon has continued to work with families and professionals by developing research-based curriculums and providing one-on-one support that empowers families to seek whole lives in their communities. Our experience in providing positive supports through technical support, such as person-centered planning and one-page profiles, has made a marked difference in the way parents and caregivers perceive the role disability plays in their child's life. In addition to our highly-valued special education trainings, FACT Oregon expanded its workshops and professional in-service presentations to include inclusive practices related to topics like recreation, employment, community-building, navigating county developmental disability services, and assistive technology. In an annual follow-up survey to families receiving special education support, 92% stated that information received was very useful, and 96% stated the information received at a workshop was very useful. Feedback included statements like, "I have moved forward much farther with the information I learned from FACT Oregon than I would have without" and "Thank you for all the wonderful work you do and the quality resource material that you share! It has changed our lives for the better knowing we can connect with others going through similar things." The survey also showed that FACT Oregon is having a transformational change in the lives of families. With seven questions asked about how views have changed on disability, each question had an increase.
