CASE MANAGEMENT WAS PROVIDED TO EVERYONE IN OUR HOMELESS SHELTERS. OUR FEEDING PROGRAM SERVED 132,913 MEALS. OUR LIFE RECOVERY PROGRAMS ENROLLED 83 MEN AND 46 WOMEN, SOME WOMEN WITH THEIR CHILDREN. EDUCATION IS PROVIDED AS A PART OF THESE PROGRAMS, INCLUDING VOCATIONAL TRAINING, BASIC LIFE SKILLS, GED PREPARATION, COLLEGE ENROLLMENT, AND ADULT LITERACY.
