THE CLUB REQUIRES MEMBERS TO PAY A NOMINAL MONTHLY FEE AND IN TURN, IT PROVIDES A GROCERY STORE LIKE ENVIRONMENT THAT INCLUDES PLENTY OF FRESH FOOD OPTIONS AND A WIDE VARIETY OF CHOICE. MEMBER DIGNITY IS AT THE CORE. THE FOOD CLUB IS LOCATED AT HOME REPAIR SERVICES AND HRS ACTS AS THE FIDUCIARY AND EMPLOYER OF RECORD.
