Tapestry Folkdance Center (Tapestry) provided approximately 1,250 programming hours with a total attendance of 17,200 from July 1, 2016 through June 30, 2017. Tapestry's main programming falls into several weekly dance categories, including Contra, International, English Country and Bollywood. Tapestry also offers a variety of biweekly, monthly and seasonal programs, including Waltz, Line Dance, Family Dance and Ballroom. Tapestry offers two annual events drawing audiences from within and beyond the region: fall International Weekend and spring Call of the Loon Contra dance weekend. Tapestry contracted with about 230 artists to present programs. With the Minnesota History Center, Tapestry continued its annual partnership to cosponsor Nine Nights of Music and provided dance instructors for the evening concerts. Tapestry also provided over 1,500 hours of affordable studio use to organizations and individuals for rehearsals, dances or classes in music and/or dance as well as for programs utilizing movement for wellness and body awareness. Tapestry in the past year enhanced the facility by installing ADA compliant automatic entrance doors, installed more energy efficient lighting and did facade and roof repair.
