NEXTGEN CLIMATE ACTION WITH AND GAVE UNRESTRICTED GRANTS TO ORGANIZATIONS THAT WERE CONDUCTING NON-PARTISAN VOTER REGISTRATION DRIVES FOCUSED ON THE "RISING AMERICAN ELECTORATE" CONSISTING OF MILLENNIALS, LATINOS, AND UNMARRIED WOMEN. VOTERS IN THESE DEMOGRAPHIC GROUPS SUPPORT POLICIES TO ADDRESS PROGRESSIVE ISSUES AT A MUCH HIGHER RATE THAN THE ELECTORATE AS A WHOLE. WORKING WITH THESE ORGANIZATIONS, NEXTGEN CLIMATE ACTION REGISTERED HUNDREDS OF THOUSANDS OF NEW VOTERS. ENVIRONMENTAL LEADERSHIPNEXTGEN CLIMATE ACTION CONTINUED TO LEAD AN EFFORT TO STRENGTHEN CLIMATE AWARENESS AND OTHER PROGRESSIVE PUBLIC POLICY, BOTH NATION-WIDE AND IN CALIFORNIA.
