THE FIRST SESSION FOCUSED ON LEAD EXPOSURE IN THE SCHOOL AND EARLY LEARNING ENVIRONMENT AND FEATURED A PEDIATRICIAN, PRINCIPLE OF AN ENVIRONMENTAL CONSULTING FIRM, AND ADJUNCT PROFESSOR/FOUNDER OF A CHILDREN'S ENVIRONMENTAL HEALTH NONPROFIT. THE SESSION FOCUSED ON ADDRESSING THE SOURCES OF LEAD, THE DANGERS THE HAZARD POSES TO HEALTH, AS WELL AS HOW TO PREVENT AND REMEDIATE THE HAZARD. SPECIFICALLY, LEAD IN DRINKING WATER, PAINT/DUST AND SOIL WERE ADDRESSED. THE SECOND ONLINE SEMINAR ADDRESSED RADON IN THE SCHOOL AND EARLY LEARNING ENVIRONMENT AND FEATURED STAFF MEMBERS WITH THE AMERICAN LUNG ASSOCIATION AND PA DEPARTMENT OF ENVIRONMENTAL PROTECTION. LIKE THE LEAD WEBINAR, THIS SESSION ADDRESSED THE DANGERS OF RADON, AS WELL AS PREVENTION, TESTING AND MITIGATION STRATEGIES. HEALTHY SCHOOLS PA WORKS CLOSELY WITH THE SCHOOL COMMUNITY, INCLUDING ADMINISTRATORS, STAFF (SCHOOL NURSES, FACILITY DIRECTORS, FOOD SERVICE DIRECTORS), TEACHERS AND PARENTS, TO IDENTIFY AND REMEDIATE ENVIRONMENTAL RISKS IN SCHOOLS ACROSS SOUTH WESTERN PA. WE PROVIDE INFORMATION, SUPPORT, AND HANDS-ON ASSISTANCE SO THAT CHILDREN CAN THRIVE AND LEARN IN HEALTHY, TOXIC-FREE SETTINGS. THESE SCHOOLS WERE CELEBRATED FOR IMPLEMENTING INITIATIVES FOCUSED ON CREATING A GREEN AND HEALTHY LEARNING ENVIRONMENT FOR THEIR SCHOOL COMMUNITY. THE 2016-2017 HONOREES INCLUDE EDEN HALL UPPER ELEMENTARY AND WEXFORD ELEMENTARY IN THE PINE-RICHLAND SCHOOL DISTRICT, ENVIRONMENTAL CHARTER SCHOOL, GREENOCK ELEMENTARY SCHOOL IN THE ELIZABETH FORWARD SCHOOL DISTRICT, KISKI AREA UPPER ELEMENTARY AND KISKI AREA HIGH SCHOOL IN THE KISKI AREA SCHOOL DISTRICT, REGENCY PARK ELEMENTARY IN THE PLUM BOROUGH SCHOOL DISTRICT, AND SHADY SIDE ACADEMY. THE TOTAL NUMBER OF STUDENTS IMPACTED BY THEIR SCHOOL'S CHANGES TOWARDS A HEALTHIER ENVIRONMENT WAS 5,220. A CHECKLIST GUIDES SCHOOLS THROUGH THE PROCESS. HEALTHY SCHOOLS PA'S ASSISTANCE IS PROVIDED FREE OF CHARGE WITH OFTEN LITTLE TO NO-COST SOLUTIONS FOR MANY ITEMS ON THE CHECKLIST.
