The organization launched an SMS Patient Registry and initiated support for a post doctoral fellow to be funded for two years. The PAB advises the Board of Directors and the programming and services. In 2017, a research grant totaling 150,000 and a grant to fund a genetic counselor position totaling 10,000 were awarded.
