To provide a place in perpetuity where people with disabilities can be successful, equal and capable, growing to their maximum life's potential through interaction with horses in a positive environment. We accomplish our mission by providing recreational, educational, and sport programming, including recreational/recreational opportunities to youth at risk and persons with disabilities. Individuals are accepted without regard to race, religion, ethnicity, or socioeconomic background.

Teaching people with disabilities to ride and care for horses and preparing them to show at the Top Hanas Horse Show. Despite Hurricane Harvey, in 2017 we taught 665 lessons to 67 riders with disabilities. A team of 17 riders participated in the Top Hanas horse Show (HLS&R) earning 4 first, 3 second, 8 third, 5 fourth, 4 fifth, 2 sixth, and 10 participation awards. Additionally families took pride in these accomplishments, related and enjoyed being a part of an accepting community as well as encouraging further education with potential employment goals. We held a spring picnic and gathering at which time we introduced the Why statement: Living Life without Labels. The families again hosted a December on-site open house. School age students gained in positive behavior and communication skills as well as other areas.

Providing adjudicated youth with the opportunity to serve their assigned community service hours - This included teaching them to use a garden rake and shovel to clean and repair the facility. Seventeen adjudicated youth completed 168 hours of community service, weeding our fence line, under and around our ramps, cleaning our horse trailers, and on special occasions helping with the horse program. Upon completion of the program they have a better understanding of how to stay out of trouble. Success rate is 25% returning them to positive life choices.

Utilizing volunteers to feed and care for our horses, instruct our people with disabilities, supervise adjudicated youth, maintain the facility, and complete all administrative and fundraising work - A total of 127 volunteers (including the adjudicated youths) gave 4,078 hours to operate Dream Catcher Stables program. This does NOT include administrative or fundraising work. Of the totals we had 42 dedicated volunteers who gave 3,462 total hours. Board members gave a total of 1,748 hours, and a one time special group of 5 gave 125 hours to our program. Many of our volunteers are high school students who leave us when they go on to college. While in our program they learn how to effectively interact and work with people with disabilities AND learn the capabilities of our athletes. In recent years two of those volunteers have chosen therapeutic fields, several are pursuing their medical interests (human or animal), and one of those therapeutic students has graduated and returned to volunteer with us.
