Land Conservation GVLT furthered its mission to conserve working farms and ranches, wildlife habitat, and river corridors in the Gallatin Valley in FY17. We collaborated with two families to conserve 658 acres of land in Gallatin County. These projects included critical wildlife habitat and agriculturally significant farmland near Bozeman. This brings our total conserved land to over 45,800 acres in 102 conservation easements. We visit each of these conservation easements and landowners annually to provide stewardship support and monitoring to those properties. In FY17, we assisted 12 stewardship enhancement projects on the ground, worth a total of \$32,900 to enhance forest health, control noxious weeds, and plant streamside and wetland vegetation.

## **Form 990, Part III, Line 4b:**

Community Trails - In FY17, GVLTs Community Trails Program continued with its mission to connect people, communities, and the land through collaborative trail projects. In our 27-year history, GVLT has helped create over 80 miles of trail. This year we constructed the Stockyard Connector, a trail linking the Story Mill Spur Trail with the soon-to-be-constructed Path to the M, secured two vital trail easements to connect the Painted Hills Gap trail, installed a trail counter on the Gallagator Trail to analyze usage patterns, and coordinated the Trail Ambassador program with 10 partner organizations to use volunteer trail ambassadors for education and outreach with over 1,200 trail users.

### **Form 990, Part III, Line 4c:**

Education The GVLT website is updated monthly with current news relating to community trails, private land conservation and events open to the public. Our website also hosts a transparency section with our Audit, annual report, and Form 990. We communicate with over 14,000 community members through a monthly electronic newsletter and social media channels such as Facebook, Twitter, and Instagram. In FY17 we utilized 1,039 volunteers who gave over 2,900 hours to the organization, and all volunteers are educated about the mission and accomplishments of GVLT during their service. The free Discovery Walks program guided 373 people to learn about GVLT, the trails, and interesting topics like wildflowers, birds, yoga and more.
