Clients shop at no cost and receive a 1 month supply of 25 targeted items including toilet paper, soap, laundry detergent, and feminine hygiene products. During 2017 \$24,000 of items were given from the NonFood Pantry. Christmas Assistance allows clients to select up to \$75 in new toys for every child in their home ages 0-12. Parents with children 13 years of age through college receive \$75 in gift cards to Target or Walmart per child.
