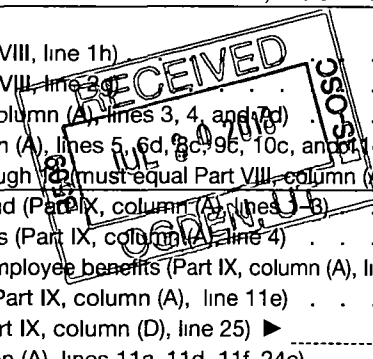

The Touchet Valley Arts Council promotes fine arts in the Touchet Valley and surrounding area including, but not limited to, music, art, motion pictures, oral interpretation, and live theater. We present current and classic movies, live community dramatic and musical theater, youth theater, and civic events.

FILM/CINEMA. The organization presented current movies, usually a new film each week, usually 4 days a week, except when live performances take over the theater, to make cinema available in this rural area, and at reasonable admission prices to make it affordable. The films are selected mainly for general family viewing. Matinee and some special showings are at further reduced prices. Some films have special Sensory-Friendly showings. Subsidized very-low price showings are part of our Summer Cultural Enrichment Program for youth. Special film showings may accompany fund-raising events, community events, holidays, and other seasonal activities.

LIVE THEATER PRODUCTIONS: The organization presented several live theater events, produced, directed and performed by volunteers from the Touchet Valley and surrounding area. Cast members range from about 5 to 90 years of age, and some have resided over 30 miles away. Cast size occasionally exceeds 60 persons, which fills our tiny stage. This provided entertainment for the community, and recreation, education, and comraderie for participants, as well as experience in teamwork, leadership, and the performing arts. Events included a major musical in the Fall, comedy, melodrama, and reader's theater; a variety show with song, dance, and other talents; and concerts by a range of visiting performing artists from western music to jazz to classic string quartet. Youth theater experiences included the Missoula Children's Theatre noted below.

EDUCATIONAL AND COMMUNITY EVENTS: The organization provided use of the theater for community forums and educational events, and occasional private events, throughout the year at a nominal usage fee. The fee is sometimes waived for other community organizations. The organization also arranged for local artists to display their paintings and sculptures in the theater lobby on a continuing rotation. The Summer Cultural Enrichment Program for youth is a free or low-cost program, largely supported by grants, which included a series of 5 movies and the Missoula Children's Theatre. Missoula Children's Theatre brings a week-long youth theater workshop and performances involving multiple children of age 6 to 18, at no cost to the participants.

Four Directors are also elected Officers. No Officers or Directors receive any compensation from the organization. No Board members have business dealings with the organization.

(B) Part X, line 10a and line 10b (Property Basis and Accumulated Depreciation) on this year's Form 990 both match the total value shown in our QuickBooks 6/30/17 Statement of Financial Position, therefore it is considered correct to use these numbers. However, Part X, line 10a on last year's Form 990 does not match this year's Basis, even though QuickBooks shows the two years are the same. One cannot determine how this different number was determined. Therefore one also does not know how they determined the amount of that year's depreciation. This also might affect the reported Net Assets.

(C) This preparer does not suspect any wrongdoing, but suspects the independent accountant who prepared the Form 990 last year may have used different sources or different methods than this year. This preparer was not able to determine the exact sources of the discrepancy, therefore it was judged that a single "adjustment" on Part XI, line 9, was the best way to reconcile the Net Assets.

FORM 990, Part XII, LINE 2B - FINANCIAL STATEMENTS AND REPORTING. The 2015 return for FY 2016 was compiled by, and also underwent Financial Review by, an outside accountant. This is not done every year, and is not planned for this 2016 return nor FY 2017 financial records.
