The California Alliance for Arts Education is pleased to present a report on our major program accomplishments and highlights. During fiscal year 2017, the Alliance continued its Arts Now Campaign and Student Voices Campaign, supported our Arts Now Communities, empowered California school districts across the state to increase arts education through Local Control Funding Formula (LCFF) advocacy and the Arts Now Planning Initiative, and partnered with the California County Superintendents Educational Services Association and the California Department of Education to strengthen the Title I policy pathway. Arts Now Campaign & Student Voices Campaign On January 6, 2017, the Alliance hosted the Arts Now Humboldt Summit. The Summit was a region-wide conference that offered strategies and resources for bringing arts education to rural school districts. Approximately 100 school leaders, teachers, and community partners from Northern Humboldt Union High School District shared how they have increased opportunities for creative learning through collaboration, partnerships within Humboldt's creative economy, and programs that engage local artists and art organizations in classrooms. Highlights of the day included student performances, speaker panels, an Arts Ed Data Project presentation, and classroom visits. The 2017 Student Voices Campaign launched in November 2016 and ran until April 2017. The Campaign is a video advocacy program that provides California public school students in grades 7-12 with a means to directly communicate school goals to local board members as well as learn about school policymaking. Leading up to the Student Voices Campaign, we organized events and produced informational documents intended to facilitate the participation of local advocates in the LCFF planning processes in their districts. For example, the Student Leadership Lab identified, documented, and shared examples of effective student leadership training and student-led advocacy. Moreover, a revised version of the Student Voices Campaign Classroom Guide was released in the fall for teachers to use during the school year. The Guide structures the Campaign as an interdisciplinary, service-learning classroom project that includes elements of civic participation, creative expression, media production, and community engagement. On January 11, 2017, we hosted a webinar attended by 23 teachers about how to use and integrate the Guide into curricula. We also collaborated with Arts for LA to produce the Activate Student Voices Guide, a resource for arts organizations to embed the Campaign's civic engagement processes into existing youth programs. We ultimately received 101 videos from students located in eight different counties across California, a 66% increase in submissions from the previous year. The 2017 Student Voices Summit & Screening, the culminating event of the Campaign and part of the Arts Now California Summit series, was held on April 29th at Plaza de la Raza in Los Angeles. Over 100 students, teachers, parents, and arts education leaders from all over California attended the Summit, which featured student advocacy presentations and opportunities to learn about careers in the state's creative industries. The day included a panel discussion with professionals from film and television, music production, aerospace engineering, automotive design, and fashion. Students were also able to participate in a variety of creative workshops such as filmmaking, animation, and theatre. The event concluded with a screening of finalist videos and an awards ceremony. Arts Now Communities In FY2017, we supported our 23 existing Arts Now Communities by providing them with one-on-one coaching, professional development, technical support, and advocacy best practices. We will continue our efforts to identify new leaders in other districts and counties. Our Local Advocacy Retreat was held on September 21 and 22, 2017 in Riverside. The retreat featured training about topics necessary to lead vibrant and productive Arts Now Communities. The first day featured a think tank about assessing the arts education landscape in your community and a panel about building relationships with district leadership. The second day included a facilitated discussion about shaping ideas for an action plan and time dedicated to working on action plans with Alliance coaches. Twenty-two Arts Now Community leaders from all over California attended the retreat and participated in the intensive training. LCFF Materials We have enriched and strengthened our 23 local advocacy coalitions throughout California and provided them with technical support and professional development. On our website, artsed411.org, we host a Coalition Blog that serves as a space where local groups can share their success stories and advocacy strategies. Significant posts to the blog include "Building Relationships with School Leaders in San Benito County and "Strategic Communications with District Leadership: Creating Arts Champions!" Through initiatives such as the Coalition Blog, the Alliance helps communities across California connect, share their experiences, and support each other in their arts advocacy efforts. We worked to address equity and access to arts education in California schools by working with CreateCA to promote the Arts Education Data Project. The Data Project provides important information to education leaders, teachers, and parents about levels of access to and enrollment in arts courses in California schools. The Alliance has promoted the Data Project in our communications and webinars and has incorporated Data Project content into our Arts Now Campaign events. In addition, we have partnered with CreateCA on smaller, regional events that feature the Data Project and present arts planning and local advocacy as key strategies to increase access to the arts. This suite of tools has motivated school leaders in a new way to increase participation and ensure student success in arts education. In July and August 2017, the Alliance completed a scan of 53 LCAPs from districts where the Alliance has provided strategic support. The analysis of the LCAPs revealed exciting results about the impact of our work in these districts. 49 out of the 53 districts included arts in their LCAP (92.5%). In addition, 18 districts included increases in arts funding between 2018-2019 and 2019-2020 academic years. Our analysis found that in districts that have taken part in the Alliance's LCFF programs and training, there has been a steady increase in the number that include arts in their plans and budgets. The most recent LCAP scan demonstrates the Alliance programs have been successful in convincing school boards to commit LCFF funding to support arts education and arts integration strategies across the curriculum Arts Now Planning Initiative In an effort to ensure quality and equity in district arts programs, the Alliance developed the Arts Now Planning Initiative, which provides strategic assistance, high caliber facilitation, and financial support to help school districts and counties complete an Arts Plan. In partnership with Arts for All, the Alliance released an updated version of The Insider's Guide to Arts Education Planning, which includes information about the Local Control Funding Formula and other current considerations for arts planners. In March, in partnership with CreateCA and the California County Superintendents Educational Services Association (CCSESA), the Alliance offered an Insider's Guide training to Visual and Performing Arts (VAPA) staffers so that they could facilitate arts planning in their communities. In addition, the Alliance worked directly with one county and two districts on Strategic Arts Plans. In July, the Alliance hosted an "Insider's Guide Train the Trainer" session in collaboration with CCSESA Title I Initiative. The Alliance is partnering with the California County Superintendents Educational Services Association (CCSESA) in consultation with the California Department of Education to develop a voluntary cohort of regional leaders who are engaging in deeper work around Title I across the state. The Alliance contracted with a consultant to develop five sample school site plans demonstrating how to incorporate arts into Title I planning compliant with state and federal law. These five plans are on the www.title1arts.org website and are being used as a linchpin of the CCSESA learning cohort.
