The Horticulture Program designs, installs, and maintains the Gardens 78 acres of living native plant collections and historic landmarks. The Garden has several distinctive sections that highlight the breadth of species across Californias diverse landscape. The newest garden displays offer updated inspiration for conserving water and using natives in home gardens, introduce deciduous natives in a shaded, canyon setting, showcase plants of the Channel Islands with a breadth-taking view of the islands themselves, engage children with a maze made of native Coyote Bush, and introduce visitors to Californias rarest and most threatened species. The Horticulture team also manages two native plant nurseries, one open to the public for plant purchases and the other for propagation.

They examine the beneficial role native plants play in supporting pollination and pest control for healthier and more productive food crops and wildlands. The team also manages a seed bank and a herbarium. By using cryogenics, they maintain a comprehensive collection of genetic material from California's most imperiled plants.

The Educational Program supports the Gardens conservation mission by inspiring active stewardship of native plants & the environments that depend on them. We work to develop an environmentally literate & engaged public through on-site classes, lectures, travel, & docent-led public & school tours. Garden school tours increase the eco-literacy of children in ways that are interactive and relevant to their daily lives and interests.
