The Adventist Health White Memorial Charitable Foundation supports Adventist Health White Memorial (AHWM), a 353-bed, not-for-profit, faith-based, teaching hospital, which provides a full range of inpatient, outpatient, emergency and diagnostic services to the communities in and near downtown Los Angeles. One of the greatest assets an organization can possess is the trust of its community, both on campus and in the surrounding neighborhoods. Year after year, the health care needs of our community are assessed to guide the continued growth of programs and services and address those needs head on. Advancements were made in heart care, our first transcatheter aortic valve replacement (TAVR), a less-invasive valve replacement procedure that does not require open-heart surgery, was performed this year, making elderly heart patients in our community eligible for a procedure that can add years to their lives. The Cecilia Gonzalez De La Hoya Cancer Center, named for the late mother of professional boxer and philanthropist Oscar De La Hoya, addresses the high incidence of breast cancer in our community, featuring sophisticated diagnostic and treatment equipment, bilingual breast cancer support groups, a community resource center and free breast exams and mammograms to the uninsured or underinsured. The care we give at AHWM follows our mission of living God's love by inspiring health, wholeness and hope. We touch the lives of people at every point throughout their lifetime beginning with exceptional prenatal and maternity care. Our Level III Neonatal Intensive Care Unit is one of the few in Los Angeles for newborns in need of advanced specialized care. The AHWM Cleft Palate Program focuses on providing the surgeries and support for children with this birth defect, including restoring normal function with minimal scarring, dentistry and speech therapy to help correct speaking difficulties. Mental and emotional health services are provided for all ages. Our Community Information Center, formed in 2014 to meet the need to educate our community on the Affordable Care Act and assist with health care insurance enrollment has grown to offer many more services to our surrounding Los Angeles community members. In partnership with Mexican American Opportunity Foundation (MAOF) and other not-for-profit partners, the Viva Bien program is a vital part of our seniors' lives, giving a place to connect, activities to help improve health and fitness, as well as assistance with accessibility and mobility. One of Adventist Health White Memorials signature efforts, the Workforce Development Program serves as an incubator for youth and young adults seeking work experience and exposure to careers in health care. Miguel Ruiz first started as an AHWM volunteer in high school and after college returned to the hospital as an intern with the Bank of America Career Pathways Program, which fosters future health professionals among local youth by teaching vital job skills. Miguel's dream of working in medicine came true when he was hired at the hospital in 2014 working in the same-day surgery department. Having the opportunity to volunteer, intern and work there were experiences that definitely helped make my dream of going to medical school a reality. Like Miguel, Victor M. Gonzalez Luis was an intern with the Career Pathways Program. After completing the program, he began working at the hospital. White Memorial is a great hospital and I am proud that I was able to work there in admitting and same-day surgery, said Victor. Maybe I will work there again, but next time it will be as a doctor! He earned his B.S. in microbiology at California State University, Los Angeles and now attends the University of California, San Francisco School of Medicine. Ronald Castillo volunteered with Adventist Health White Memorials Family Medicine Residency Program and served as a promotor (community health worker). He recently received an acceptance offer from the University of Southern California's Keck School of Medicine. Ronald's career goal is to become a primary care physician. I am so grateful for the help, support and mentorship that I received at White Memorial, says Ronald. I learned so much from the physicians and all the staff. Their examples and encouragement helped inspire me to stay committed to my goal and work hard. Research has demonstrated that a healthcare workforce, which reflects its patient population increases access to care and improves quality. This is why we are fortunate that forty percent of Adventist Health White Memorial employees are from the hospitals surrounding community service area, many of them have started with the hospital as volunteers and interns.
