As of June 26, 2017, The Atlantic Foundation assumed responsibility for The Mangrove Foundation's outstanding grant obligations and liabilities in the amount of \$97,347,280 in exchange for funds of an equivalent amount. The residual value of Mangrove, \$7,395,393, was also transferred to the Atlantic Foundation in the form of a grant of \$12,395,393 offset by the assumption by The Atlantic Foundation of responsibility for \$5,000,000 in "conditional" Mangrove grants that had not been treated as liabilities on Mangroves books due to their "conditional" status.

The Atlantic Foundation was an initial funder of The Mangrove Foundation having provided a contribution of \$60.2m when it was formed in 1999. The Mangrove Foundation and The Atlantic Foundation, both Bermuda based charities, are part of "The Atlantic Philanthropies", a group of related charities that will give away all of their assets and close their doors by the end of 2020.
