Transitional Living Center Expenses paid for groceries, health care, supplies, travel, telecommunications and other educational expenses for the care and maintenance of the foster children as they are equipped to transition into society as functioning contributing adults. In Addition, property and other living expenses to provide living quarters for the aged out foster youth as they transition out of the foster system. Angel Reach is first committed to assuring the safety and security of all children and youth in alternate care. Expenses includes Rent, electricity, insurance, taxes and other utilities provided for their care and maintenance.
