EducationSeveral schools received grants this past year. St. Mary's Basic School in Montego Bay region serves pre-school children and received support grants. Scholarships for tuition, books, supplies, uniforms, or lunch programs were funded for 368 students at St. Pius X, St. Peter Claver, Immaculate Conception, St. Benedict's and Montego Bay Diocese. The DuPont school received funding for a Parent Literacy program, sports equipment and musical instruments. A summer program was funded at Holy Trinity and overhead fans were installed in all classrooms at Immaculate Conception. The St. Pius X adult Skills Training Center (cosmetology, food prep) serving 43 students was also supported. All these services to the poorest of the poor will inspire students to improve their quality of life and avoid inner city poverty, crime and drug problems in the future.

MedicalThe medical clinic at St. Pius X in Kingston, Jamaica operates 3 days per week, with a part-time local physician who provides care on a deeply discounted basis. The clinic is open to all indigent patients in the poor neighborhood of St. Pius, regardless of ability to pay, or church affiliation. We estimate an average of 87 patients visit the clinic per month, i.e., 1,000 patient visits per year. Jamaica Outreach Program supplies the clinic with medicine. The clinic dispensary supplies patients with medications free of charge. The Sacred Heart clinic at remote Seaford Town in Montego Bay region saw 99 patients treated during one mission trip, medicines were funded and distributed, and medical equipment and supplies were donated. The Good Shepherd Foundation clinic in Montego Bay received a grant as well. Reported amounts exclude non-cash medical services valued at \$7,760.
