THIS ADJUSTMENT INVOLVED RECLASSIFYING \$8,240 OF DEFERRED REVENUE TO UNRESTRICTED NET ASSETS FOR AMOUNTS THAT SHOULD HAVE BEEN RECOGNIZED AS REVENUE PRIOR TO JUNE 30, 2017. AN ADJUSTMENT WAS ALSO MADE TO RECOGNIZE INCOME FOR THE YEAR ENDING JUNE 30, 2017, AND ADVERTISING INCOME WAS INCREASED BY \$1,200 AS A RESULT OF THIS CORRECTION. THE 2016 (06/30/2017) FORM 990 AND 990-T WILL BE AMENDED TO RECOGNIZE THESE REVENUE ADJUSTMENTS.
