COMMUNITY BUILDING - IN 2018, WRV BUILT AND MAINTAINED A PASSIONATE, HIGHLY SKILLED VOLUNTEER COMMUNITY THAT CARES FOR PUBLIC AND ECOLOGICALLY IMPORTANT LANDS. WRV WAS ABLE TO COMPLETE 138 RESTORATION EVENTS BECAUSE THIS GROUP CONTRIBUTED OVER 883,500 WORTH OF LABOR AND EXPERTISE. THESE VOLUNTEERS BENEFITTED 1,725 ACRES OF WILDLIFE HABITAT IN 2018 ALONE. THIS IS ONLY POSSIBLE BECAUSE OF THE DEDICATION OF DONORS, VOLUNTEERS, AND VOLUNTEER LEADERS. WRV'S VOLUNTEERS ARE SO COMMITTED THAT WE CURRENTLY HAVE 493 VOLUNTEERS WHO HAVE COMPLETED TEN PROJECTS, 27 VOLUNTEERS WHO HAVE COMPLETED 100 PROJECTS, AND 31% OF VOLUNTEERS ATTENDED MORE THAN ONE PROJECT DURING THE YEAR. IN 2018, WRV HELD 19 COURSES AND TRAINED 213 VOLUNTEERS IN TECHNICAL, LEADERSHIP AND SAFETY SKILLS. SINCE 2003, WRV HAS TRAINED MORE THAN 3,200 VOLUNTEER LEADERS IN SKILLS INCLUDING RESTORATION DESIGN, CREW LEADERSHIP, TRAIL MAINTENANCE AND CONSTRUCTION. 2018 REVENUE 4,481 2018 EXPENSE 128,308 FAMILIES & YOUTH - TIME SPENT IN NATURE PROVIDES DEMONSTRATED MENTAL HEALTH BENEFITS, ESPECIALLY FOR CHILDREN. WRV PROVIDES DIVERSE YOUTH WITH BROAD ENVIRONMENTAL EDUCATION EXPERIENCES, BEGINNING WITH KNOWLEDGE & AWARENESS, LEADING TO CRITICAL THINKING, PROBLEM SOLVING & DECISION-MAKING, CONCLUDING WITH SERVICE AND COMMUNITY LEADERSHIP IN ECOLOGICAL STEWARDSHIP. STUDENTS LEARN RESTORATION TECHNIQUES, ECOSYSTEM SCIENCE AND TEAMWORK. SOME YOUTH GO ON TO TAKE HIGH SCHOOL CREW LEADER TRAINING, WHERE THEY LEARN INTERPERSONAL SKILLS FOR LEADING CREWS OF YOUTH AND ADULTS IN THE FIELD. WRV AND OUR PARTNERS HOST YOUTH EXPLORING STEWARDSHIP, A TWO-DAY ANNUAL CONFERENCE FOR YOUTH LEADERS FROM A BROAD ARRAY OF REGIONAL ENVIRONMENTAL ORGANIZATIONS. IN 2018 ALONE, WRV ENGAGED OVER 800 YOUTH IN RESTORATION & LEADERSHIP DEVELOPMENT. THESE YOUTH PLANTED OVER 1,200 PLANTS AND RESEEDED OVER 13,000 FT². 2018 REVENUE 3,500 2018 EXPENSE 89,825 INVASIVE WEEDS - INVASIVE WEEDS THREATEN TO OVERTAKE OUR NATURAL LANDS, CROWDING OUT NATIVE PLANTS AND ANIMALS, AND WEAKENING THE ECOSYSTEM. WRV FOCUSES OUR EFFORTS MOSTLY ON WEEDS WHICH ARE LEGALLY MANDATED FOR ERADICATION. OVER WRV'S HISTORY, OUR VOLUNTEERS HAVE WEEDED OVER 6,117 ACRES OVER THE LAST 17 YEARS. WRV VOLUNTEERS' HARD WORK HAS REDUCED THE MEDITERRANEAN SAGE POPULATION BY 95% OVER HUNDREDS OF ACRES. SINCE A SINGLE MATURE PLANT CAN PRODUCE 100,000 SEEDS, THESE NUMBERS REPRESENT SIGNIFICANT MOMENTUM. FOR MYRTLE SPURGE, WRV'S INNOVATIVE PRIVATE LANDOWNER PARTNERSHIP HAS HELPED TO ADDRESS THOUSANDS OF ACRES THAT BORDER PUBLIC LANDS IN THE FOOTHILLS. AS A RESULT OF THESE PROJECTS AND MANY OTHERS, THOUSANDS OF RESIDENTS NOW CAN IDENTIFY AND SAFELY REMOVE THESE INVASIVE SPECIES, PREVENTING THE DAMAGE THEY DO TO NATIVE HABITAT. IN 2018, VOLUNTEERS WEEDED OVER 332 ACRES. 2018 REVENUE 38,313 2018 EXPENSE 66,185 HEALTHY FORESTS - COLORADO FORESTS HAVE BEEN AFFECTED BY UNNATURAL FIRE SUPPRESSION FOR DECADES, AND THROUGH FOREST THINNING AND REMOVAL OF INVASIVE TREE SPECIES, WE CAN HELP RARE NATIVE SPECIES RETURN. TRAINED VOLUNTEERS USE CHAINSAWS TO CONDUCT FOREST THINNING PROJECTS IN THE WILDLAND-URBAN INTERFACE AND UTILIZE WOODY MATERIAL FOR NEARBY HABITAT RESTORATION. IN ADDITION TO THINNING, VOLUNTEER CHAINSAW OPERATORS HELP WITH TRAIL CORRIDOR CLEARING AFTER BARK BEETLE DEADFALL AND REMOVE INVASIVE TREE SPECIES SUCH AS RUSSIAN OLIVE. IN 2018 ALONE, WRV SAWYERS RESTORED 31 ACRES TO FOREST HEALTH. 2018 REVENUE 5,000 2018 EXPENSE 45,074 NATIVE SEEDS - RESTORATION PROJECTS REQUIRE A DIVERSE SUPPLY OF NATIVE TREES, SHRUBS, GRASSES AND WILDFLOWERS THAT ARE GENETICALLY ADAPTED TO THRIVE IN THIS AREA. PEOPLE OF ALL AGES JOIN US TO COLLECT, CLEAN, AND GROW-OUT NATIVE SEEDS. VOLUNTEERS ALSO HELP TEND PLANTS IN A GREENHOUSE AND NURSERY. OVER WRV'S 19-YEAR HISTORY, VOLUNTEERS HAVE CONTRIBUTED OVER 30,000 HOURS TO THE NATIVE SEED PROGRAM. IN 2019, 520 VOLUNTEERS SPENT OVER 1,500 HOURS COLLECTING NATIVE SEEDS TO BE GROWN-OUT AND USED ON FUTURE PROJECTS. 2018 REVENUE 32,389 2018 EXPENSE 42,562
