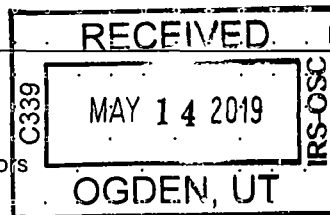

The Music Stand successfully launched our concert series with the help of our location partner this year, UTD School of Arts & Humanities. As mentioned, North Texas Giving Day has been a great fundraising resource for us and allows us to be introduced more potential donors. We were able to continue our personal development series for musicians at the Meadows Conference Center in Dallas, a facility that offers space to nonprofits at no cost (a very helpful resource to keep our costs down since didn't have the budget to rent a venue). We were not able to secure a host for our creative education program but are continuing to explore options to launch the program. The Music Stand is still researching grants to suit our program needs and looking for land & building for physical location. Overall, we made significant progress from 2017 and reached our major program goals.

Part IV List of Officers, Directors, Trustees, and Key Employees

In 2018, we had three new board members join our team, all of whom have valuable expertise in fundraising, nonprofit management, strategic planning, development and marketing/promotions. All of them have a heart for music and serving people as well as offer great vision to help The Music Stand grow and thrive. This year did not bring in enough revenue to hire staff or offer benefits, so we will continue to press forward with our goals and search for sustainable funding for this purpose.
