NorthBridge is becoming the premier college success program for students with learning differences as well as being the Valley's expert on transitioning to postsecondary education.

 NorthBridge was founded on the principle that college-aged young adults with learning differences can excel in post secondary education with specialized and individualized support. NorthBridge provides students with a multi-layered support system that focuses on both academic success and personal development. The program includes individualized academic advisement, weekly academic support sessions, individual mentoring sessions, student success workshops, and coordinated social events. NorthBridge served 746 students through the 2017-18 program year. NorthBridge has now supported over 650 students in coaching and college retention. NorthBridge entered into a partnership with Phoenix Union High School District and Valley of the Sun United Way, which resulted in a substantial increase in Accuplacer Ready enrollment. Through this partnership, NorthBridge was able to provide Accuplacer workshops to over 550 Phoenix Union High School students. The TechForce Scholarship Ambassador Program showed dramatic results with improving retention among the 96 MM/UTL Ambassador students. Ambassadors had a 99% retention rate, compared to an average 59% retention rate of non-program students.
